His object in going to Meerut was to sell gold, silver and other goods in the Meerut market. Whilst he was passing through the Chaupla Bazar with this object, he was taken into custody by three police constables on suspicion of being in possession of stolen property. His belongings were then searched and he was taken to the Kotwali police station. He was detained in the police lock-up there and his belongings in which consisted of gold, weighing 103 tolas 6 mashas and 1 ratti, and silver weighing 2 maunds and 6 1/2 seers, were seized from him and kept in police custody.
